The fight for prime land and water continues

We are now 3 years into this battle. But, if the community had not kicked up a real stink; if the Blockade had not been established and kept going to press for a water study; if CCAG had not received your financial support, time and energy; if the community hadn't received the support of politicians and, through media interest and personal networks, the backing of country and city-folk across Australia; if the whole exploration process and its irregularities had not been brought out into the open via the courts, mining may well have started by now. We, a proud rural community, have shown how credible demands, backed by facts, figures and "People Power" really can have a dramatic impact on events.

In this newsletter, we are offering an update on where the fight is at. We thank those who were present at our recent AGM to hear some of this. We have a long way to go, but remain confident the tide will continue to turn in favour of food production and protection of vital water supplies. These issues are gaining traction in the wider community as people wonder where indeed our food will come from if Australia has 40 million people to feed by 2050!

The Water Study

The process for the catchment-wide water study is coming along. There is still negotiation over funding, although BHP has pledged to contribute, as has the Federal Government. The make up of the Ministerial Oversight Committee has been determined and the Stakeholders Advisory Group (SAG) is in progress. From our community, John Clements, Fiona Simson and Tim Duddy are all on the SAG.

Legal challenges We have two main fronts here: a Supreme Court action challenging the Mining Warden's rulings re: access in Brown and Alcorn supported by the AFFF (Feb 2010). The Land Environment Court is presiding over the issue of the validity of the Licence 6505. The Minister for Mineral Resources and BHP-Billiton has been jointly named as

defendants in these proceedings. Following our enquiries we believe that EL6505 is not valid, we believe that the proper process of tending and re-issuing of the licence did not occur and the environmental issues the Minister was obliged to address PRIOR to the issuing of the licence were not properly taken into consideration. Again we are looking to set precedents.

The Political arena

Political understanding and support is crucial to the success of this campaign. We have hosted many visits by politicians from all political parties and have been encouraged by their interest and the resulting greater understanding of the issues. CCAG and the community recently took part in two Senate enquiries: *The Agricultural and Related Industries enquiry into Food Production in Australia*, and *the Environment, Communications & Arts enquiry into the Impacts of Mining in the Murray Darling Basin*. Thanks to all in the community who contributed written and oral submissions – these really make a difference. Transcripts are available via the Senate and CCAG website – they make fascinating reading. Both of these enquiries also visited the “at-risk” farming communities on the Darling Downs in QLD. We await the outcomes of these important enquiries with great interest.

Media presence

We continue to enjoy strong media interest and are grateful to all of those who write into the local, state and national press, please keep going. The 4 Corners program in July generated a lot of enquiries regarding how to help and also financial support. Many city folk were appalled that mining was even being contemplated on Prime Agricultural Land.

The Blockade

Now going strong for 15 months, Blockade support is as committed as ever. It remains a focal point of our campaign to ensure the independent water study occurs and we welcome visitors from out of the area and the frequent politician visits. Water Quality Benchmarking Programme

CCAG Round 1 water quality testing is complete with Round 2 in progress for consistency. Many in the community, inside and outside the ELs, are to be congratulated for their personal commitment to the forensic benchmarking of their economic base without any Government or other financial support. Round 1 and Round 2 testing needs to be completed as a matter of urgency, ideally before any exploration drilling occurs in the landholder's area. Applications from anywhere in the Liverpool Plains catchment are still invited. No Round 3 testing will be done in the short-term. Round 4 testing will not be required if the previous rounds are consistent. Please address interest and queries to John Polglase (0407 011 732).
